God can and did move men to write accurate history about many events that neither they nor any other human ever personally saw.

- 10. Only two verses are ever cited by old-earth proponents as an objection to this claim: Zechariah 14:7 and Hosea 6:2. But in the first case, the context of verses 14:1, 4, and 6 shows that they are referring to the same unique day (in Hebrew yom ehad, just as at the end of Gen 1:5), the day the Lord returns at the end of the age. The Messiah Jesus is not going to return over long ages, but suddenly, in an instant ("in the twinkling of an eye:" 1 Cor 15:52 and 1 Thess 4:13ff). In Hosea, the prophet calls the people to repentance and gives a promise

of spiritual healing and reviving "after two days" and "on the third day." But it is no comfort if it doesn't mean that God will quickly respond mercifully to their returning to the Lord. What would it mean if the promise was that God would revive them two to three hundred (or thousand or million) years after they repent? The promise only makes sense when we take the days literally and take the phrases as meaning "quickly." Neither of these verses shows that yom modified by a number can mean something other than a literal day.








Sedimentary Rock Layers


Andromeda Galaxy






- 51. Building a new form of animal life requires innovation in form and structure. New protein folds—the subunits of large-scale structure out of which whole proteins are made constitute the smallest unit of structural innovation in the history of life. Thus, a novel protein fold represents the smallest unit of innovation that natural selection can detect. Since building fundamentally new forms of life requires structural innovation, mutations must generate new protein folds for natural selection to have an opportunity to preserve and accumulate structural or morphological innovations. Thus, the ability to produce new protein folds represents a sine qua non of macroevolutionary innovation. For this reason, Douglas Axe's experiments tested the difficulty of generating new protein folds, not just new protein functions within an existing folded structure. Though random mutations may produce slight changes in protein functions within a common proteins fold (i.e., without producing a new fold), Axe's work showing that the extreme rarity (and isolation) of novel folds within amino acid sequence space suggested that generating a novel fold requires more new information than could be reasonably expected to arise given the probabilistic resources available to earth's evolutionary history. Thus, Axe's experiments also suggested an informational limit to the creative power of the mutation and selection.
